Your answer form should say any defense or explanation that you might have. It is very important to write down any defenses you want to tell the court. If you do not put a defense in your answer you may not be allowed to talk about it later in the case. You may also make a counterclaim in your Answer. Ask the Court Clerk if the court has an Answer form for you to use or you can make your own.

Answering a Consumer Debt Case | NY CourtHelp

The defendant's answer tells the court and the other party whether they agree or disagree with each of the statements from the complaint, or that they neither agree nor disagree with a statement because they don't have enough information. If the defendant disagrees with a statement from the complaint, they can explain why they disagree.
